## President's Message

As I began writing this President's Message, I found that I was a bit at a loss for fancy words and creative metaphors. So, I decided I would just present some bullet points here to let you know what is happening here on Herron Island.

*Our Water System:* The necessary permits have been issued, the official Notice to Proceed has been given, and the work has begun. The contractor is digging trenches and laying pipe. A new fence surrounds the well site. Construction progress is good. You should expect to shortly see a large map of the island posted at the top of the hill at Ferry Street, showing the location and current status of water system work on the island. Also, we are making some desirable upgrades to the entire system, including the installation of meters that can be read electronically, as well as replacing our aging pumps with modern, efficient pumps.

*Our Parks:* April 28, 2012 is Parks Appreciation Day on Herron Island. Our Parks Volunteers plan to install the small boat docks alongside the new pilings at North Beach, and install fence sections at the Nature Park and at North Beach. The B.O.O.S.T.E.R.S. are dedicating their April meeting and their membership's positive energy and labor to the Parks Appreciation Day. More information on this can be found later in this edition of the Beachcomber.

*Budget and Finance:* The Finance Committee is fine-tuning its proposed Budgets for Fiscal Year 2012-2013 and should be sending the final versions to the Board soon for its evaluation. The Finance Committee is also looking at a new study of our reserves and into the possibility of obtaining a grant for the replacement of our ferry engines.

*Spring Burn:* We will not be conducting a spring burn this year at North Beach; the burn that was scheduled

for Saturday, May 19 at North Beach has been cancelled. Most likely, we will be discontinuing these community burns altogether because of the costs and cleanup efforts involved, and the availability of other ways for individual property owners to dispose of natural yard debris.

*Security:* Reports have been received that cars have been vandalized in the mainland parking lot, and that gas has been stolen from them. We're looking at ways to improve the security on the mainland parking lot, including investigating the availability of grants through the U.S. Department of Homeland Security.

*Facilities Inspection:* Our ferry docks and ramps are fairly good shape, but we are planning some required maintenance to ensure that they stay that way. The inspection report by Sargent Engineers can be found on the Herron Island website.

*Committee Activity:* The Emergency Preparedness Committee, the Parks Committee, the Land Use Committee, the Rules Committee, and the Roads Committee are alive and well! They are actively meeting and working harder than ever to improve the quality of life on our island.

*Website Revisions:* Along with other improvements, we have revised the calendar on the Herron Island [website](#) so that it is easier to read and track our various island activities – check it out.

Feel free to contact me with any kudos or praise for our numerous island volunteers and for the way our island is being run. And feel free to contact our Island Manager with any complaints or criticisms you have. Well ... you can let me know those as well. Enjoy the sun!

## **Island Manager Report March 10, 2012**

### **Administration:**

**Volunteers:** Many thanks to those who have continued to pursue island cleanup, including windfall limbs and branches, cleaning the waiting shed and other general help. Thanks to Rich Urfer for assisting with searching for grant opportunities to replace our ferry engines, in order to reduce fuel consumption and maintenance costs.

**Island Cleanup:** Still awaiting final clearance from Tacoma-Pierce County Health Department on 1015 West Yew and 117 E. Madrona. PCResponds and the Tacoma-Pierce County Health Department have been very cooperative in all the island cleanup efforts.

### **Water System Project:**

Work has begun on the first loop, around East and West Madrona, beginning from the well site. The hydrant at the well site will be replaced as soon as possible. Fire District 16 is aware of its removal and expressed no concern regarding the short outage. The second loop to be completed will be the large north end loop from Maple to West Herron/North Beach and down East Herron back to Maple. At this point the contractor will have two crews working on the island. In the short term, excess dirt will be deposited at the intersection of West Yew, West Herron and West Madrona until transfer can be arranged to other sites on the "dirt list". The first priority will be to use excess dirt on HMC sites, then on individual member sites in the order of request.

The project fencing is also completed.

We have prepared our first payment request to reimburse HMC and to pay the contractor for the fencing, materials and labor. This payment request has to pass several hurdles and we are please to say we made it! Including a site visit from USDA

**Action Needed:** Peninsula Light has provided a design and proposed contract agreement for the upgrade to three phase power at the pump house. This portion of the project needs to proceed soon, and the agreement, for \$38,622.40, is well within the \$50,000 estimated in the project budget. Board approval recommended.

**ADA Compliance:** Gary Wanzong took measurements of the women's restroom, and we are contacting the USDA architect for design assistance. This work will be separately contracted.

### **Water Advisory Committee:**

This new committee, which will advise the IM and Board on water operations issues, will meet for the first time Friday April 20th at 10:00 at the Community Center. The committee is looking for members and will write the charter, mission statement, and choose a chairman at the 1st meeting. If you are interested, please contact Judy Greinke or the HMC Office.

### **Cross Connection Control Program:**

This issue is one which should be assigned to a reconstituted Water Advisory Committee. Those Member connections that have a direct water line to a hot tub, closed fire protection system, pool and/or in ground sprinkling system will be required to install a certified backflow prevention device, register it with the Utility, and have it inspected annually.

**Fire Department Liaison:** A date of May 19<sup>th</sup> has been tentatively set for an island burn. The Fire District informs us that new regulations require that the burn pile be no larger than 10'x10'. In addition to concern about the size of the burn pile, they are concerned about random dumping by members once they see the pile growing, despite the cutoff date for dumping. Assuming "people play by the rules" they will issue a permit for the annual burn.

**Land Use:** The Land Use Committee's draft policy and procedure regarding sale of HMC lots has been thoroughly reviewed and is near completion, following a lot of hard work and careful thought by committee members.

**Emergency Preparedness:** Committee report.

Although I did not attend the most recent Hazard Mitigation meeting at Pierce County, I did provide an update of some materials to the coordinator. PCDEM is asking that we confirm the update and return it to the coordinator, Katie Gillespie, and so I will be forwarding that document to the Emergency Preparedness Committee for review.

**Legal Liaison:** There are currently 11 delinquencies, of which seven are with the island attorney. This is a delinquency rate of 2.8%.

**Parks: Committee Report**

*Committee members are working together to complete the planning for our Parks Appreciation Day and Small Boat Dock Installation on April 28<sup>th</sup>. Great Parks help make our community stronger, connecting individuals, families and groups through the power of play. Be part of this effort. We would like volunteers to come prepared with gloves, rakes, and shovels. (Please remember to mark them with your name.) This event will be followed by a potluck style lunch for participants. We have a great deal to accomplish and hope we get the volunteers to complete our tasks.*

**The Parks Committee would like the Board to make an exception to Rule F1(f) which states:** "Open fires are prohibited in island parks and other common areas unless specifically authorized in advance by the Board or the Island Manager or when confined to the single designated site on the beach at the North Beach Park. All open fires are subject to all restrictions imposed by Pierce County Fire District No. 16 and any additional restrictions imposed by the Board." **We would like to have an open fire on the North Beach parking lot during on our Parks Appreciation Day to burn the downed branches from the various parks.**

*The Parks Committee would like permission from the Board to install a staggered split rail fence at the south end boundaries of both the Nature Park and North Beach. These fences would be to mark our boundaries yet would leave access open.*

*Mike Shettlesworth has been working hard to make the refitting adjustments to the small boat docks. He is hoping to complete this task before installation on April 28<sup>th</sup>. We have not yet heard when Quigg Brothers will install the additional collar.*

*We would like to thank Mike Shettlesworth, Kris Mullan, Dick Mowry, John Farris, Tracy Anspach, Kathy Deuster, Dana Gruber and Jack Wells for the extra time and work they have put in this past month on behalf of all our parks.*

**Nature Park:** After hours and hours of volunteer work, Nature Park has been cleared of storm debris. Thanks to the neighbor who allowed small pile burning of debris from the park.

**North Beach Marina:**

This project is substantially complete, but a final collar is required on the foremost float. Quigg Brothers should be completing the project this week or early next week, depending on the tides..

**Roads:** The newly reconstituted Roads Committee has met and produced a Charter and Mission Statement. Jack Wells is chairing the committee. Merry Kogut is assisting with the drafting of a Charter and Mission Statement.

Action Needed: Board consideration and approval of the Committee Charter and Mission Statement.

Rules: There are no pending complaints. The redrafting of the Rules continues.

Transportation:

We finally received our stability letter from the Coast Guard, reducing our passenger load to 45, plus a crew of 2. This recalculation was based on a change in the average passenger weight.

The Coast Guard has announced it may randomly audit Chemical Testing programs (drug and alcohol tests) during periodic inspections. To make certain things are in order, I have been going through records, provider contracts and services to be sure we can satisfactorily respond to an audit. While our testing program is in compliance, we need to have all other records in order.

Waste Oil: HMC has now engaged Arcon, a local company, to pick up waste oil, filters and rags from the ferry. This is a new service, replacing one previously supplied by a member at no cost, but should only cost a few hundred dollars annually.

Pierce County Wharf Easement Inspection:

Sargent Engineering has issued its report on the mainland and island side docks, ramps and lifting systems. Their report finds that the facilities are well maintained and in good condition, with a couple exceptions. First, they recommend replacing a couple of timbers on the deck of the ramp, and secondly, one of the mainland cables appears to be wearing and should be replaced soon. The remainder of the report addresses the same issues of rust removal and painting, but the overall report is good. This evaluation and report is required by Pierce County, from whom HMC leases the mainland dock area, and by our insurance carrier, for use in setting our annual premium.

Technology: No report.

EMERGENCY PREPAREDNESS  
TIP OF THE MONTH

The shaking has stopped but the damage is extreme. You've secured your immediate environment but your constant thought is, "how is my family?" The cell phone isn't working, the internet is down, and the local landline phone system has shut down. How do you contact your loved ones?

Designate a Contact Person

Long-distance calls are still possible on a landline. Ask an out-of-town friend or relative to be your contact person. This person should live at least 100 miles away from you. After a disaster, all household members call this person to tell her or him how they are and to find out how other family members are.

Make small cards with your contact person's name and phone number for all family members to carry in their wallets, purses, or backpacks as well as making sure you've entered your contact person's information into the contacts lists in your electronic devices.

Did you know?

- **It's difficult to make local calls not because of damage, but because of the number of people trying to call at the same time. Typically, however, you can make long distance calls. Phone lines were "hardened" years ago to withstand nuclear attack and are quite resistant to damage.**
- One reason the local phone system shuts down during earthquakes is because handsets get knocked from their bases. Help restore local phone service by making sure all your phones are hung up.
- You should keep a phone that does not require electricity. Cordless phones use electricity! When the power is out, they will not work.
- Pay phones are part of the emergency services network, and are a priority to be restored to service. You can tape the coins needed to use a pay phone to your Out-of-Area Contact card.





## **RESIDENTIAL FIRE PIT ETIQUETTE**

Now that summer is just around the corner, we're dreaming of those balmy evenings with family and friends gathered around our fire pits. The air is full of laughter, shared memories, and the aroma of S'mores. While all this is wonderful, legal, and fun, we need to remember that our "good times" may be a nuisance and, in some cases, a hazard to our neighbors. Here are some simple suggestions so that you can be a "good neighbor" while enjoying your fire pit.

- Burn only dry firewood. Generate as little smoke as possible.
- Check the wind direction.
- Notify your neighbors in advance.
- **Better yet ... invite your neighbor.**
- Be sensitive to the neighbor who may have asthma or other breathing difficulties.
- **Even a "hot" fire emits the smell of smoke so consider how frequently you have a fire.**
- Remember to refrain from loud voices, loud music, etc. between the hours of 10 pm and 8 am.



Per the Puget Sound Clean Air Agency, it's always illegal to smoke out your neighbors. If they complain, you are required to put the fire out immediately.

### **Additionally**

- Any outdoor fire must be continuously attended. Abandoning a fire could result in heavy fines.
- Burning of trash is never allowed.

## Water Project FAQs

**Q:** How do we know what the contractor is doing each day?

**A:** USDA requires that we have Resident Project Representatives (or inspectors) on site each day, with log books and digital cameras. These inspectors are all HMC Members – Dana Gruber, Mike Shettlesworth, Charles Smith, and Rich Urfer. Each day they watch the contractor at work and record the progress. Among their responsibilities is also testing the compaction of the soil, using a special instrument purchased for that purpose. If they have any concerns, they contact the project engineer directly.

**Q:** Last week trenches were left open at the end of the week. What are we doing about this safety issue?

**A:** Our project engineer has asked Massana Construction to close the trenches at the end of the day, if that is possible. If it is not possible, then Massana will use traffic cones to clearly mark the site.

**Q:** How can I find out where they're going to be working?

**A:** The Board has asked us to put up a map at the top of ferry hill, so that progress can be noted for everyone to see. This will take us a few days, but look for the map soon.

**Q:** The contractor didn't bring any extra fill dirt over at the beginning of the project. Aren't they supposed to use new fill dirt?

**A:** One of the inspector's jobs is to be sure that the contractor is putting proper soil under and around the water pipes. If our soil meets the standards required, then no additional fill dirt will be needed. Unfortunately, that means that the "dirt list" of Members asking for soil, might not get much use.

## Tansy Ragwort Removal

Tansy ragwort is one of the more serious noxious weed problems in Western Washington. In fact, **Tansy is considered #1 on Pierce County's 'Terrible Ten' list!**

Tansy ragwort has made beautiful Herron Island its home. Tansy contains alkaloids that can accumulate and cause liver damage in livestock and pets, making it extremely toxic. It also displaces desirable plants due to its aggressive growth and prolific seed production.

The effort and cooperation made by Herron Island property owners in the control of Tansy ragwort has steadily increased, and together we are making progress!

Control methods for Tansy ragwort include:

- Digging up the plant with the roots.
- Applying appropriate herbicide.
- Bagging flowers and throwing them in the garbage.
- Maintaining a healthy, vigorous cover of desirable plants.

Methods that *do not* work:

- Mowing will not control Tansy ragwort. Tansy will re-flower.
- Do not leave flowers on the ground. They can still go to seed.

Licensed Weed Inspectors from the Pierce County Noxious Weed Control Board will begin making routine inspections on the Island beginning the last week in May. If Tansy ragwort plants are discovered on your property, please eradicate them as soon as possible. 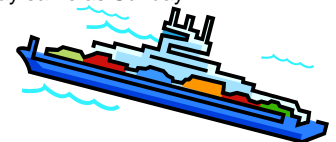

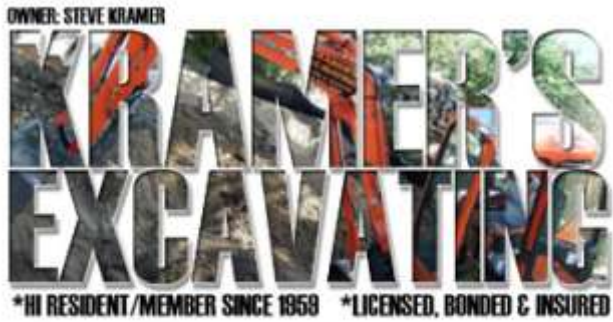
